Membership Drive Begins

Happy Holidays to our WRRRA friends and cabin neighbors!

We hope you are well and have had the opportunity to enjoy your cabin during this wonderful time of year. It's that time again for our annual WRRRA membership renewal. The process will be similar to last year. All members with email information on file will be receiving an email explaining how to become members in 2024.

In a nutshell, on the WRRRA web page, go to membership, then online membership, which will take you to the WRRRA Square site, where you can pay your membership fee(s) by credit card, debit card or ACH. As mentioned in the previous newsletter, the WRRRA Executive Board discussed and voted unanimously to increase the membership dues to \$50. They also voted unanimously to increase the membership dues to \$60 for payments received after the official membership drive ends on February 15th. These increases were shared with the general membership at the Fall Dinner Meeting. Remember that each cabin can have up to 4 members. There is an unlimited number of "Associate Memberships" allowed per cabin. Associate memberships are an excellent way to get the next generation of cabin owners involved in WRRRA. Thank you again for your continued support of our cabin association.

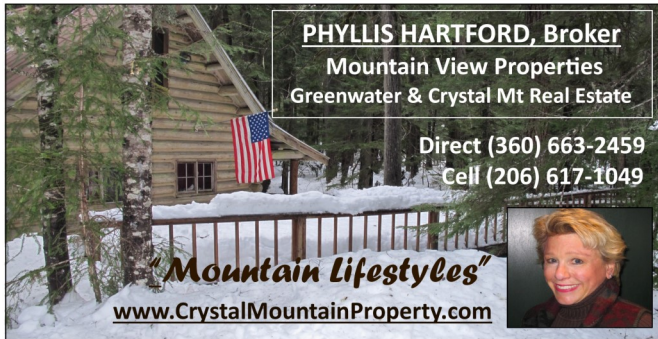

WRRRA is comprised of several hundred members and has a formal structure with elected and informal leaders. It is through the formation and the sustaining of our organization that some members have emerged to provide strong guidance and have significantly contributed to our organization and the overall cabin program.

One of those leaders was Ken Leader. Ken passed away in 2018. In his memory and as a tribute for his selfless contributions of his time, knowledgeable guidance, and direction, the board established the **“Ken Leader Outstanding Service Award.”** The intent is to acknowledge WRRRA members who have con-

Snowplow Update

Invoices were emailed 10/15/23 and a follow up email to stragglers was sent 11/14/23 from Robbin Bradburn (Snowplow 410 program coordinator) to fund the Snowplow 410 and Road Maintenance programs for SS, SC, GC and DC.

Thank you to all who responded and are participating in the Snowplow 410 and road maintenance program! As of December 4

we've had 88% of cabins pay from the emailed invoice and reminder notice. Cabins that didn't pay by December 16, 2023 will not receive plowing services; if you think you were somehow missed but want to participate, please email me at Snowplow410@live.com

We have the same contractors again and have commitments lined up for services. The first storm of the season already landed and we almost had our first plow service! If the season is lighter than expected please note that any funds not used will carry over to help fund the following year. This program also collects funds for off-winter maintenance.

Our goal is to clear the main roads after a storm slows down (or the main roads become too difficult to drive), then punch into each driveway for some parking, and finally do more driveway work when the storm abates, **all done with an emphasis for access by the weekend**. Midweek plowing will be done as necessary, primarily on the main roads.

Please mark your driveway for a plowing punch and clearly mark whatever we need to avoid (well-heads, large rocks, stumps, etc.) with sturdy PVC pipes or posts at least 4 feet out of the ground, striped with reflective tape for when we plow after dark.

Forest Service and General Updates

After several failed attempts to meet with the new FS management since former District Ranger Martie Schram retired last year, members of the WRRRA board were able to

meet with new District Ranger Heather Randall Wilder and our Special Uses Administrator Brian Lee via a Zoom videoconference call in late September. WRRRA board members in attendance included President Kevin Orth, Past President Rena Irwin, Vice President Fred Orton, Silver Springs Rep Ken Ring, and Dalles Rep Anne Schopf.

Although many of us had a chance to meet new Ranger Wilder when she attended the WRRRA Summer Picnic this year, we had not had the opportunity to sit down and discuss issues since our last meeting with Ranger Schram in July 2022, so it had been over a year since our last formal connect.

After introductions, we got into some of the key topics.

Culvert Replacement

The replacement plan for the Goat Creek culvert which was removed in 2017 continues to see little movement. As previously noted, it is not a high priority for the FS; all cabin owners have access to cabins, and although safety and accessibility is improved with that road, it is not an urgent need. The washout of the culvert at Dry Creek provided additional concern about flooding on Goat Creek. Additionally, the gap may need to be covered by a bridge, which obviously increases the cost and effort significantly. We will continue to pursue a plan of action here for this coming year.

Dispersed Campsites & Crime

The dispersed campsites along the 410 corridor by the White River are an ongoing concern for crime in our cabin tracts. We talked about perhaps blocking the roads leading into the campsites either with guardrails or placing boulders at the road entrances; the cost of the guardrails is probably too much but perhaps placing boulders and no camping signs at the road entrances may be feasible. Retained Fees from permits might be used to do something like this.

Access and Camping on Cabin Lots

The public can access and camp on our cabin lots, it is public land; but they cannot impede our access to the cabins or roads. That is enforceable by FS law enforcement. While access or camping on the lot may affect our ability to use or enjoy the lot, it is not illegal as this is public property.

Projects Process & Timeline

Brian confirmed that while Projects can be submitted at any time to him, they have to be submitted by September 30 for consideration for the following year. In-kind replacements, hazard trees, and simple things don't require project submission during the open window, can come and be approved at any time -- this process and window is just for bigger projects like additions, septic system, etc.

Unauthorized Work Issues

Brian did mention that there seemed to be some recent instances of unapproved work being done in the cabin area. Reminder to members that no unauthorized major work on the cabin or cabin sites should take place as there could be significant consequences for doing that (fines, permit termination).

Permit Renewal / Retained Fees

The FS team have no key concerns anticipated on the Permit Renewal Process. The FS is thinking about how to use the Retained Fees coming from the implementation of that program.

All agreed we should continue to try to get together every 4 months, as we have previously done.

WRRRA Planning and Goals for 2024

The WRRRA Board met on November 27, to review Goals and accomplishments for 2023, brainstorm and prioritize Goals and plans for the organization for 2024, update the various Committees and members contributing to accomplishing the work, and to align on the Budget for 2024.

Goals and Budget

While we made some good progress against some of our goals for 2023, including development of Relationships with the new Forest Service personnel and advocating for the retention of the Enumclaw office, plus education for members on Crime prevention and reporting, the key Technology goals were left undone as we were unsuccessful in getting that work off the ground.

The board all agreed that for 2024 we should fully focus on implementation of a new system that will allow us to consolidate from three da-

tabases to one, which will also help reduce secretary and treasurer workload. And, the hope is that a new data management system will also help via upgrades to the website and the email distribution management processes.

The project is now budgeted for 2024, and member dues have been raised in part to help address this urgent need. A Technology Committee may be formed and tasked with making recommendations to the board for implementation in 2024. Please let us know if you have interest in helping here.

Request for Help

We have many committees and the board can only do so much on our own; we need help, and hope that some of you will volunteer to participate in the committees or project teams that will tackle key topics this next year.

We have committees that need help from members including the below list:

- Technology: New database management system; improve internet access for members
- Social: Planning and executing on social events including the dinners and picnic
- Infrastructure: Emergency preparedness, crime and safety
- Fundraising: Planning and execution of the Auction and other fundraising events
- History: Developing a historical account of WRRR through stories and pictures

NFH Fall Forum Recap

The NFH Annual Fall Forum was held in Bozeman, Montana on September 23, 2023. It was well attended by cabin owners from Montana and other Northwestern states, as well as Forest Service personnel from the area, and NFH board and staff.



The Fall Forum is a regional mini-conference, focusing on a few key areas of interest for the region. This forum focused on hearing from regional and national Forest Service staff, learning about Wildfire Crisis Management Strategy for the forest, and learning more about how to Advocate for the cabin program as we prepare for changes including new permits and fee retention, and hope to revitalize the declining cabin program through the proposed new Cabin Program Restoration Act.

On Friday before the forum, NFH board members toured area cabin tracts along the Gallatin River and up to the area around West Yellowstone. We saw some beautiful and rus-

tic cabins in multiple tracts, including one on the National Register of Historic Places. And we saw some large lakefront summer homes just outside the national park. It's always so interesting to see how much cabins on forest service land differ across our forests and tracts around the country.

NFH board and staff also participated in a trails maintenance event with Forest Service staff on the famous "M Trail", as part of National Public Lands Day volunteer event. It felt really good to participate in a stewardship activity as a group; we hope to make this an ongoing part of all future conferences and forums.

Revised Permit: Successful NFH Advocacy

(The following announcement is from the NFH website.)

An objectionable and illegally inserted clause specifying a 5-month use limit has been removed from new permits, issued in 2023.

The Forest Service released a revised special use permit in spring of 2023. This permit was issued to new cabin owners or during permit transfers. NFH identified two clauses that were inserted into the permit without the required public comment period, thereby making them illegal clauses. NFH objected to several aspects of the new permit by meeting with and submitting a letter to the Forest Service Washington Office.

We are pleased to announce that NFH has successfully lobbied the Forest Service to remove the illegally-added clauses. The most troubling clause would have limited use of a cabin to 5 months each year. After repeated and direct pressure from NFH, the Forest Service has removed this and the other illegally inserted clause about a national rental policy.

For anyone who received a new permit in the year 2023, watch for an addendum to your permit. Check with your Permit Administrator, Recreation Officer or District Ranger to ask about it if you don't receive this in the next couple of months. Again, this is ONLY for those who received the new permit in 2023 with the new language including a clause with a 5-month use restriction. We are grateful that our efforts were successful and no permit holder will be subject to the 5-month limit of use.

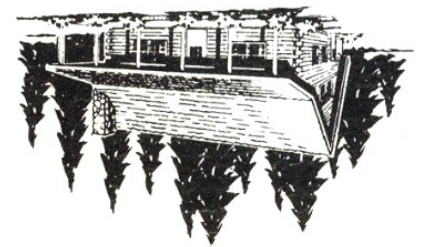
