## Directory Changes

There are some changes in the 2023-2025 edition of the WRRR directory. The board determined that the primary focus of the directory is to serve as a resource for contact information. Therefore, the decision was made to move the WRRR Constitution and Bylaws, and the Historic Summary of the USDA Forest Service Recreation Residence Program to our website: WRRR.net.

Also, in the front of the directory, where the tract and lot listings are found, it was decided to list all cabins (rather than just those of WRRR members). For those cabins with WRRR members, the names listed are the members. If a cabin had no current WRRR members we listed the individual who is identified by Pierce County Tax records (a public record) as the person of record. Those individuals are identified with an asterisk (\*). Thank you to Rena Irwin for scouring those tax records to find the names of those individuals. Only WRRR members and associates are found in the Alphabetical listings, address/phone number section.

By now you've likely received your directory. You may have noticed a change in the distribution. As more cabins have multiple memberships, it made sense to send **two directories to only one of the cabin members** (one directory intended for the cabin, one for their home), **with each other cabin member receiving just one directory for their home**. Since more and more cabins have multiple WRRR members, it seemed excessive to send 4, 6, 8, even 14 directories to the members of a single cabin. It made fiscal sense, but more importantly, it's better for our environment. ## Snow Plows are Coming!

Our snowplow and road maintenance program is preparing for this next year. We plan to assess \$350 per cabin this year (\$275 snowplow & \$75 roads), \$25 less than last year. Look for an emailed invoice in mid-October with program details.

In the meantime, please mark your driveway for a plowing punch and clearly mark whatever we need to avoid (well-heads, large rocks, stumps, etc.) with PVC pipes or posts at least 4 feet out of the ground, striped with reflective tape for when we plow at night. ## Crystal Mountain Update

It has been a very busy summer at Crystal this year.

We opened the Flying Raven Adventure Course and had a blast swinging through the trees with our guests in our first-ever high-ropes course. We worked diligently making updates to our resort operations and offerings, including adding a yurt at Midway (top of Chinook, bottom of Rainier Express) for quick refreshments, snacks, or a meeting location while you explore Crystal this winter. We also added 36 RV spots to parking Lot G that will house both nightly and seasonal RV guests, and we extended the Visitor's Information Center's hours to include winter, so while you travel HWY-410, there is a place to stop and check-in. We didn't stop there.

As you know, the new building is getting close to completion! We are hopeful that the first floor of the Mountain Commons building will open at the begin-

ning of the 23/24 ski season. When you walk into the first level of the building, you'll be greeted by two new venues. Brew 62 Café will provide all the early morning coffee needs, proudly brewing Starbucks coffee and, in the afternoon, have the best PNW brew (beer) on tap, as well as grab-n-go snacks and sandwiches. The other venue on the first level is a new retail space, Crystal Outfitters, where you can find the latest hard goods like helmets and poles or this season's soft goods like The North Face jackets and Dakine gloves. Crystal Outfitters will be the home of Crystal branded gear, shirts, mugs, maps, and more.

The second floor of the Mountain Commons building is dedicated to food and beverage and is expected to open around the holidays. This floor houses a quick-serve style restaurant and overlooks the meadow area with an indoor/outdoor bar. This level will remain closed until it is ready for operation.

This year, we are excited to announce the installation of RFID gates at the base area lifts (Gondola, Chinook, and Discovery). The new gates will mean that once you have your ticket (current pass or new RFID day ticket), you can leave it in your pocket for the day and focus more time on enjoying the hill. To redeem, purchase, or pick up your ticket, you can find the ticket booths, once located in the parking lot, have moved closer to the north end of the Mountain Commons building, and all our ticket pick-up boxes have moved into the new plaza in a concentrated area closer to the bottom of the gondola. We added 5 new, easy-access, transit-style busses to service and will have dedicated bus stops to expedite guests to and from the parking lots.

Once on the hill, you'll notice some additional grading projects have taken place. The "football field" area of Queens Run has been widened, and the steep section flattened out to make for a better experience for our beginner guests. We've regraded the lower section of Mr. Magoo, smoothing it out as well, and put in a

permanent ski way to the Northway area between Snorting Elk Bowl and Gate 4; this will allow easier access for our guests. This will also assist with easier access for the grooming crew to get a snowcat down to the bottom of the lift.

In years past, we've taken many steps in the right direction regarding sustainability. In the last year alone, we dedicated more resources to sorting trash and were able to reduce our landfill runs by 75%. This year, we're taking strides. After receiving a grant for a commercial composter, we will now do all composting on-site, and that in addition to our recycling efforts, we hope to continue to reduce the amount of waste we send to the landfill.

Even with all this change, we continue to look to the future. We have full approval to replace the Rainier Express lift starting in the summer of 2024. As you may remember, Rainier Express (REX) was the first high-speed lift installed in Washington state back in 1988. The new lift will run just about the same line. The bottom terminal will move back slightly to the Southwest, lookers left, of its current location, giving skiers and riders a little more "breathing room" as they get off at the top of Chinook and on at the bottom of REX.

We're honored to call you members of our community. We thank you for your patience during construction and support as we continue to grow. We look forward to seeing you on the hill this winter.

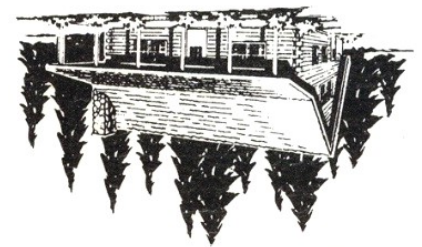
