Happy 2023 to our WRRRA friends and cabin neighbors:

We hope you are doing well and have been able to enjoy your cabin during this wonderful time of the year. These last couple of years have been challenging and yet a visit to our cabins can often provide a much-needed reprieve. The economy and specifically inflation, has certainly taken a toll on all of us and WRRRA has felt this financial squeeze. Every expense that your association has incurred has increased. The good news is that, even with these increased operating expenses, we have decided **NOT** to increase our 2023 dues. Therefore it is vitally important that we not only renew our memberships but encourage other cabin family members and neighbors to join.

The process for renewal will be the same as last year. All current WRRRA members with email information on file will be receiving renewal notices at the beginning of the new year.

Besides a printable invoice attached to the email, there will be a "pay" button which you can use to pay your renewals by credit card, debit card or ACH. Like last year, we are hoping you will renew your membership now, so we can complete the process by early February, 2023.

#### What if I have not given you my email address?

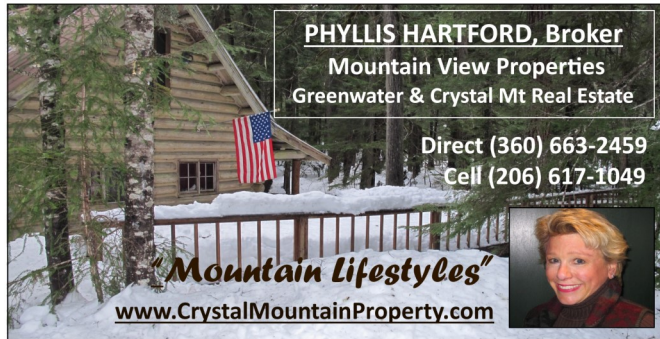

## Albert Pollmar Awarded Ken Leader Distinguished Service Award.

This Board Award was established as a lasting tribute to Ken Leader for his many contributions to WRRRA over many years. It was announced in 2021 to the membership. The Award is given to a member who has demonstrated significant and unusual service and leadership. Nominated by a peer member of WRRRA, Albert is recognized for his broad contributions not only touching WRRRA but also to Washington State Forest Homeowners (WSFHA) and National Forest Homeowner (NFH) Associations over a long period of time, ultimately benefiting the cabin program.

He has been willing to address very complex and often political situations head on, working with





others to come to a meaningful and positive outcome for the whole. He is respected by peers as an expert on many challenging issues cabin owners face. Over and over, he has been called on for assistance or guidance and gave willingly.

He has been a leader in WRRRA, serving in multiple offices, President, Secretary and Goat Creek Rep over a period of 17 years. His contributions were significant during that time because the national Forest Service began rumblings focused on raising cabin permit fees based on unrealistic appraisals, broadly sparking awareness among cabin owners that this was the time to organize in the best interest of saving our cabins. When President, he called for establishing the WRRRA Cabin Defense Fund which membership agreed to, and still supports. Established in 2001, the fund continues to be successfully supported by several activities as well as individual contributions.

Albert was among the founding officers (secretary) of WSFHA in 1999, an office he held for 10 years. While continuing in that role he was elected President in 2004 and held that office for six years. While involved with WSFHA, he concurrently participated at the National organization level in many ways for many years. While declining invitations to be a NFH Board member he chose to contribute in other ways. For example, he served as Chair of one of the three strategic committees of the NFH Cabin Coalition, addressing the cabin Fee structure. He chaired the Fee Research Committee and prepared a 250-page briefing book for the participants at a special conference to discuss issues and competing proposals that could make a difference to our fees, long term.

Under his watch and his pen, WRRRA received the *NFH Newsletter of the Year* award in 2001. Additionally, in 2011 he was given the prized award of *NFH Volunteer of the Year* award, for his volunteerism where it really counted. In recent years, he recommended to NFH establish a leadership award in honor of and named for the former NFH Executive Director, Bob Ervin, who gave lengthy and steady guidance to the national association. NFH implemented that suggestion.

Albert has been generous with his time, commitment, and knowledge for many decades. It was with high enthusiasm the WRRRA Board bestowed this award for all that he has done on behalf of the cabin community.

Please come join others from the cabin community at this event and hopefully we can all partake in some fun sledding or sliding! Make sure you dress appropriately, bring your own sleds or tubes, and any refreshments you may want. Parking may be tight, so please carpool or walk if possible.

In order to minimize liability for the WRRRA and cabin owners, we have a few requests to help make this a safe event:

- Participants and parents should sign a liability release (provided on site).
- Parents are strongly urged to provide safety equipment such as helmets and eye protection for all participants.

- The sliding zone will be inspected prior to the event for hazards such as rocks, branches, sharp sticks or logs; please help clear any hazards before sliding.
- Sleds and tubes should be examined before coming, to make sure there are no sharp edges or pointy things that could break skin or tear clothing.
- No standing on or sliding on the road.
- Safe and sane sliding speeds; do not build large jumps.
- Loose articles that can catch and tangle; long scarfs should be tucked in.
- Parents should remain on site for supervision of their children.

We hope to see a good turnout so this can remain an annual event!

## The Snowplow program saved!

You should all now have seen emails and invoices from Robbin Bradburn (our new volunteer to manage the Snowplow 410 program for SS, SC, GC and DC). Here is his report:

Thank you all for participating in the Snowplow 410 and road maintenance program again! As of December 1 we've had over 90% of cabins pay from the emailed invoice; past due invoices have now been mailed to the last 10%. Cabins that don't pay by December 16, 2022 will not receive plowing services.

I volunteered because I could not imagine the roads not getting plowed! It almost happened but we now have the same contractors at it again, we've already had our first storm and plow of the season, and are prepared for another winter of snow and road clearing. As always, any funds not used will carry over to help fund the following year. This program also collects funds for off-winter road maintenance.

Our goal is to clear the main roads after a storm slows down (or the main roads become too difficult to drive), then punch into each driveway for some parking, and finally do more driveway work when the storm abates, **all done with an emphasis for access by the weekend**. Midweek plowing will be done as necessary, primarily on the main roads.

Cabin owners should mark their expected driveway plowing boundaries and anything deserving caution (well-heads, large rocks, stumps, etc.) with markings at least 4 feet out of the ground and highly visible. Bright reflective tape on PVC pipes works well.

## Enumclaw Forest Service Office Closure

This is a reminder and follow up to an earlier article regarding the closure of the Forest Service office in Enumclaw. As stated earlier, there are major negative ramifications for safety, public presence, and the health of the southern portion of the Mt. Baker-Snoqualmie Nation Forest. The clock is running out on their lease, it will expire in 2024. When it does, FS staff will be moved to the North Bend Ranger Station. The decision to close the office was handed down by the regional Pacific Northwest office in 2019. According to the nonprofit Lookouts Association, the Snoqualmie Ranger District (of which the Enumclaw FS office is part of) is the second-busiest district in the U.S. Forest Service system. The concern is how well the FS staff will be able

to maintain the district and discourage illegal activities when about a quarter of their workday would be spent commuting from North Bend. Mary Coughlin, (retired FS program manager) stated “All of the recreation infrastructure the FS has up highway 410 would now be much more difficult, logistically, to manage out of the North Bend Office so things will start becoming more neglected”. The FS attempted to close the Enumclaw office in 1993 but it was averted. We hope it can once again be averted. ## Cabin Security

As most of you are aware we did have an incident in the Silver Springs tract in late September of this year where two separate cabin owners were physically and verbally assaulted. Your president did send out an email to all members whom we have contact information for, explaining the incident and **how to** and **who to** report it. The contact numbers are listed at the end of this article.

Security will always be an issue in remote areas like our cabin tracts and unfortunately in acute situations we need to depend on ourselves and our cabin neighbors for assistance. There are few options to prevent a break-in of our cabins when we are there. Some that come to mind are:

- Firearms — Very effective but there are few of us who are trained and proficient in their use and have the necessary permits and knowledge to use them.

- Pepper Spray — Can be purchased in stores such as Cabela’s, Pro Bass, or online. This can be very effective and can easily be kept by any door for easy access.
- Interior locks — Easily installed and should be used to keep all doors locked whenever inside the cabins especially if you are alone.
- A loud air horn — could be used to frighten or discourage an intruder, also would alert a cabin neighbor that there is a problem.
- Phone service — Either a land line or cell service to call 911.

As we all know there will be no immediate help from law enforcement as the closest Pierce County Sheriff is Mark Rickerson and he is stationed in Bonney Lake. We depend on each other and the more cabin owners we know the safer we will all be. We are a community, and we need to work together for all our safety. Let’s do our part to help each other stay safe.

## Changes Afoot at Alta Crystal Resort

If you have driven past Alta Crystal recently, you may have noticed the sign has been changed to “LOGE CAMPS Crystal Mountain Lodging & Provisions” as well as the addition of “Alta Crystal Cafe.” The new sign reflects new



ownership. Maureen Gilbert and Steven Musser have sold the resort to Columbia Hospitality.

I had the opportunity to meet Kyle, the new General Manager and Chris, the Assistant Manager. Chris worked for Maureen and Steve so he may be a familiar face to some. Kyle gave me a tour of the old log lodge, situated on the bank overlooking Deep Creek. The old lodge is in the process of being renovated and will eventually become the “Alta Crystal Café.” A large deck was built with a beautiful view of Deep Creek. The deck will be used in the summer for outdoor dining. The small selection of groceries, including beer and wine, currently being sold in the Alta Crystal office will be moved to the café. Opening date for this eatery is estimated to be late January or early February. The new owners are currently not in the process of applying for a liquor license.

Steve Cadematori, former owner of Alta Crystal, informed us this year marks the property’s 100<sup>th</sup> anniversary. Historians and old timers may remember this property was originally known as “Bennett’s Cabins,” which started out as floored tent frames and log cabins. When I was a child, I remember a few of the original framed one room cabins. The old log lodge and one log cabin are all that remain from the original structures.

## WRRR Planning and Goals for 2023

The WRRR Board met on November 29, to review goals and accomplishments for 2022, brainstorm and prioritize goals and plans for the organization for 2023, and to update the various Committees and members contributing to accomplishing the work.

### 2023 Goals

Some of the same goals have carried through for several years running, which is an indication that they are large and difficult to accomplish. Still, we feel we need to try to chart a course to follow and are hopeful that with some new blood we can successfully accomplish some of these bigger goals, in addition to our “regular” work.

Our brainstorming session to develop and prioritize new goals resulted in the following ranked list for the board and our organization to focus on in this coming year:

- **Database Systems** – Continue efforts to implement a system that will allow us to consolidate from 3 databases; this will also help resolve overlap of secretary and treasurer tracking. The project is budgeted, and the new Technology Committee will be tasked with making recommendations to the board for implementation in 2023.
- **Security** – Continue to develop crime prevention programs and educate members on security preparation. Work with the Forest Service on addressing dispersed campsite concerns. The Infrastructure Committee will lead the charge on this one.
- **Relationships** – Prioritize developing relationships with new Forest Service staff (new district ranger coming in), and with the Muckleshoot tribe. The Executive Committee will be on point.
- **Internet Access** – Develop plan to improve internet accessibility for more members. The Technology Committee will lead this effort.
- **Forest Service Presence** – Continue to advocate for retaining the Enumclaw office and/or





increasing Forest Service presence and service levels in our region. The Executive Committee will be on point here.

As always, the board can only do so much on our own; we need help, and hope that some of you will volunteer to participate in the committees or project teams that will work on these topics.

If any of these topics are of interest to you, or if you would like any additional information on any of the above topics, please contact any board member to volunteer to help us or for more info.

## NFH Fall Forum Recap

The NFH Annual Fall Forum was held in Boise, Idaho on September 30, 2022. It was well attended by cabin owners from Idaho, Oregon, Washington, Montana and other states, as well as Forest Service personnel from the area and NFH board and staff.

The Fall Forum is a regional mini-conference, focusing on a few key areas of interest for the region. For this forum, the focus was on hearing from Forest Service staff, learning about and discussing how to Prepare for and Reduce Risk from Wildfire in forests, and learning more about the Historic Preservation process and designation for cabins.

On Friday before the forum, NFH board members toured area cabin tracts Northeast of Boise, including Ten Mile, Long Creek, Bear Creek, and Wapiti tracts. Many of the cabin tracts in Idaho are only a few cabins, so it was interesting to see as it differs so much from our own tracts. Also

much of this area had been impacted by fire with cabins lost in some tracts; it was sobering to see.

NFH board and staff also conducted a board meeting and a strategic planning session as part of the multi-day gathering.

Copies of speaker presentations, photos, and other reference material from the Fall Forum are posted on the NFH website. Access to this valuable information is a benefit of NFH membership.

The 2023 NFH Conference will be held at the in Lake Tahoe, California next spring on May 5th and 6th. Mark your calendars, and hopefully we will see you at future conferences or forums; additional information about the conferences and forums is posted on the NFH website.

Significant damage was caused by the slide that began about 1/4 mile up the hill from the Hwy, and an impressive stream of water and mud flowed over 410 (closing 410 for almost 2 days).

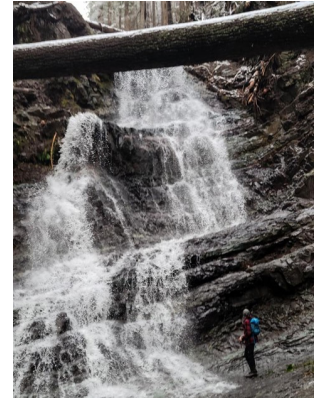
The storm also toppled trees throughout the region, took out power, dislocated propane tanks, and created a general mess near Deep Creek cabins 11 and 12.

Given the significant damage caused, the DOT and utility workers were champions in re-opening 410 and restoring power as quickly as they did. Paul Sowers praised their tireless efforts.

If you want to see the records in person your appointment will be in the basement of the U of W Allen Library South. To view online/remotely, make an appointment for online viewing. The library will provide you with a staff person who will show you page by page, item by item, the contents of the files you asked to see. 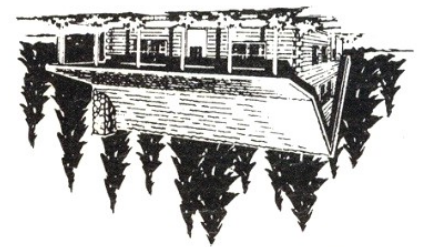
